1. Education Outreach:

- *Flower Show*: We are planning for the 2018 Flower Show, which will be held February 22-25. The theme is "Disney."

X. <u>District Manager's Report</u>

1. State Association Meeting

The NJACD approved their proposed budget. Mike Brown from NRCS spoke to everyone about the importance of more and more agencies partnering with NRCS. Districts used to be the first line partner, but now such groups as Trout in the Classroom, Pollinators in the Classroom and Ducks Unlimited have been involved. More agencies are now tapping into the federal monies available through NRSC. Mr. Brown feels there needs to be a tighter network between the district and NRCS.

NACD and NRCS have paired to offer a grant. Ines explained this grant in length and feels it is worth if for the District to apply for \$25,000 to be used towards training Courtney to assist NRCS in conservation plans. The money would cover the cost of her to be an apprentice in these tasks. Roger Gravatt made a motion to apply for the \$25,000 grant and if it is approved will readdress the uses/acceptance. Wayne VanHise seconded the motion and the motion was unanimously passed.

2. Computer Upgrades

The upgrade to MS Office 16 seems to have gone well so far. Still working some merging issues for correspondence. The next set of computers that are due to be ordered for the clerical staff will have a little bigger and better processors since these are used all day long.

3. Mapping Proposal

The new mapping system we would like to purchase is updated every 6 to 8 weeks compared to the one we currently use which has a much longer period between updates. The current proposal is for \$10,000. Ines and Mike have been speaking with them and are trying to negotiate it to \$8,500 a year for up to 5 years. More information will follow at next meeting with an update.

4. Changes to Standards

The change in the standards to include the soil compaction component will take effect on December 7th and will affect any plan received on this date and after. The SSCC had a training session yesterday with 95 attendees to discuss these changes and another training is scheduled for November 29th and it will have 95 attendees as well.

5. Truck Bids

One dealer bid and two private bids were received. Hertrich Fleet Services had the only bid for the 2018 Ford Escape and had the highest bid for the trade-in 2008 Ford Ranger. The Escape cost is \$21,110 and the Ranger trade-in value is \$4,400; therefore, making the net price to be \$16,710.00. Per resolution 2018-007, Robert Dreyer made a motion to accept the bid package from Hertrich Fleet Services. Donald Patterson seconded the motion and the motion was passed by the following roll call vote: Mr. Dreyer – yes, Mr. Patterson – yes, Mr. Gravatt – yes, Mr. Van Hise – yes and Mr. Buscaglia – yes.
