1. Next Generation Farmer Program

• The State Agriculture Development Committee (SADC) provided the District with copies of *The Next Generation of Farming in New Jersey Report on Cultivating the Future of Farming in the Garden State*. This report summarizes the challenges the next generation of farmers may face and provides recommendations for solutions to the potential challenges.

2. Fiscal Year 2026 Proposed Budget Key Points

- Category One Salaries Wages and Benefits reflects current employees as of July 1, 2025 and a potential 'Cost Share' position of an Engineer Technician, provided that funding is approved with NRCS and SADC.
- Category Six Professional Development and Public Outreach is increasing due to the addition of two (2) line items, Digital Education and Jersey Yards.
 - Digital Education craft an agreement with the Ocean County Soil Conservation District to produce digital newsletter and contact list.
 - Jersey Yards money budgeted to help expand the Jersey Yards program; currently the program is Barnegat Bay centered.
- Category Eleven Vehicle and Equipment Purchase increased due to higher prices for vehicles.
